92.5 KJJY'S "MISTLETOE MATCH 2024" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station KJJY ("Station"), 4143 109th Street, Urbandale, Iowa 50322, during available business hours Monday through Friday, on the Station website www.kjjy.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **92.5 KJJY's "MISTLETOE MATCH 2024**" Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 30 days or a prize valued at \$500 or more in the last 30 days, and whose immediate family members or household members have not won a prize from the Station in the last 30 Days or a prize valued at \$500 or more in the Station in the last 30 Days or a prize valued at \$500 or more in the 30 days. **Void where prohibited by law.** Employees of Station, Cumulus Radio LLC, and each of their parent companies, affiliates, related entities and subsidiaries, promotional sponsors, prize providers, advertising agencies, other radio stations serving the Station's DMA, and the immediate family members and household members of all such employees are not eligible to participate. 2. Contest Period. The Contest will begin at 6:00 a.m., CT on December 12, 2024 and will run until all prizes have been won (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.

- 3. How to Enter <u>On-Air</u>: Listen to the Station at 7:20 a.m. CT, 10:20 a.m. CT, 2:20 p.m. CT, and at 4:20 p.m. CT on weekdays during the Contest Period. When the Station plays the "cue-to-call" sounder, listeners should call the Station at 515-915-0925. Caller number five (5) to the Station, as determined by the Station in its sole discretion, will be selected to play. The caller must then pick two (2) numbers between one (1) and (20) if the corresponding prizes match, the caller will win that prize. If they don't match, the caller doesn't win. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished.
